**Effective 1/1/2018 Pursuant to Government Code 27388.1 documents accepted for recording MAY be charged an additional \$75.00. This fee shall be paid at the time of recording of every real estate instrument, paper, or notice required or permitted by law to be recorded, except those expressly exempted from payment of recording fees. Documents that have transfer tax, and any connected documents, the recording fee will be <b>\$14.00</b> for the first page of each document. T.C. Res. 2015-0367</p> <p><b>\$3.00</b> for each additional page of same document.</p> <p>Any document evidencing a change of ownership of real property requires a Preliminary Change of Ownership Report. A Fee of <b>\$20.00</b> will be charged if the Preliminary Change of Ownership Report does not accompany document.</p>
<p><b>Survey Monument Fee</b> GC 27585</p>	<p><b>\$10.00</b> Charge on all deeds. Exempt: Deeds conveying lots created by recorded Tract Maps, Quitclaim, Easement, Mineral and Corrected Deeds.</p>
<p><b>Multiple Title</b> GC 27361</p>	<p><b>\$21.00</b> For each title, if two or more documents are incorporated in one document. For instance "Request for Notice" in the body of "Trust Deed" a "Substitution of Trustee" with a Reconveyance.</p>
<p><b>Judgments or Liens</b> GC 27297.5 GC 27387 CC 2885 CCP 674</p>	<p><b>\$13.00</b> "Notification Fee" will be charged for each debtor or debtor's attorney to be notified of an involuntary lien or judgment recorded affecting debtor's real property in addition to the recording fee. (Govt. Code 27297.5 &amp; 27387, Civil Code Sec 2885, Code of Civil Procedure Sec. 674)</p>
<p><b>Extra indexing and additional names</b> GC 27361.2 GC 27361.8</p>	<p><b>\$1.00</b> Additional fee will be charged for each additional reference in the body of a document that has to be indexed. Reference being made to previously recorded document.</p> <p><b>\$1.00</b> Additional fee will be charged for each group of 10 names of fractional portion thereof after the initial group of 10 names that has to be indexed. Govt. Code Sec. 27361.8</p>
<p><b>Penalty Print</b> GC 27361.2</p>	<p><b>\$1.00</b> Extra for each page upon which penalty type appears. (More than 22 characters to an inch)</p>
<p><b>Release of Liens</b> GC 27361.3</p>	<p><b>\$19.00</b> For state, county, city. Documents that have transfer tax, and any connected releases, the</p>

	release recording fee will be <b>\$12.00</b> for each release. T.C. Res. 2015-0367
<b>Financing Statements UCC 9407</b>	<b>\$21.00</b> Flat fee for 1 to 2 pages of standard California form. <b>\$31.00</b> Flat fee for 3 or more pages of standard California form.
<b>Maps GC 27372</b>	<b>\$8.00</b> For the first page of each map <b>\$2.00</b> For each additional page of same map.
<b>Military Records GC 27381</b>	No recording or copy charge.
<b>Preliminary 20 Day Notice GC 27361.9 CIV 8214</b>	<b>\$58.00</b> filing fee.
<b>Official Records Copy Fee GC 27366</b>	<b>\$3.00</b> for first page of document <b>\$1.00</b> for each additional page of same document <b>\$2.00</b> additional if certified copy.
<b>Conformed Copy GC 27366</b>	<b>\$1.00</b> Per document. Requester must provide a copy of the document and a self addressed, stamped envelope.
