Description of Nature, Purpose, and Beneficiaries of Project: The project site is located northeast of the Community of Three Rivers and within its Urban Developed Boundary (UDB). The project site is zoned F-1, R-O-44 (Primary Flood Plain Zone and Single Family Estate Zone). The project includes the replacement of the 10,000 water storage tank. The tank will sit on a 100 square foot area on NKWMWC easement that is on the property. The existing water tank will be removed and recycled by the contractor.

Reasons why project is exempt:

This action is consistent with Section 15303 Class 3, New Construction or Conversion of Small Structures; in this instance, the new water storage tank will provide water for the existing community water system in the F-1, R-O-44 (Primary Flood Plain Zone and Single Family Estate Zone) zoned property. Also, replacement of a new water storage tank is consistent with the Small Community Drought Relief Program. Therefore, the use of CEQA Section 15303 is applicable and appropriate for this project.
