Description of Nature, Purpose, and Beneficiaries of Project: Special Use Permit No. PSP 24-005 is to allow a Contractor's Storage Yard on a quarter (0.25) acre portion of a 2 Acre property, in the AE-20 (Exclusive Agricultural 20-acre minimum) Zone, within the Rural Valley Lands Plan, with the Land Use Designation of Valley Agriculture. The purpose is to park and store RV, Trucks Trailers, Pickups, and work equipment. The beneficiary is the property owner.


