Description of Nature, Purpose, and Beneficiaries of Project: Zone Variance PVZ 24-008 for less than the 40 acre minimum acreage required to separate properties and Tentative Parcel Map No. PPM 23-052 to Divide 101.02-acre parcel into four parcels and a remainder Parcel 1 = 1.32-acre, Parcel 2 = 5.72-acre, Parcel 3 = 13.01-acre, Parcel 4 = 1.35-acre and a Remainder = 79.62-acres, in AE-40 (Exclusive Agricultural minimum 40-acre) Zone. The purpose is to separate Industrial operations from Agricultural land. The beneficiaries are the property owners.
