A\$3.00 additional charge will be added to each page of a document that does not comply with the size, format, quality of paper, and other related matters. GC 27201, 27361, 27361.5 & 27361.6

Effective 1/1/2018 Pursuant to Government Code 27388.1 documents accepted for recording MAY be charged an additional \$75.00. This fee shall be paid at the time of recording of every real estate instrument, paper, or notice required or permitted by law to be recorded, except those expressly exempted from payment of recording fees. The fee imposed by this code shall not exceed \$225.00.
