- 1 If you submit your order in person, you must present a valid photo ID (government issued) and sign a sworn statement in the presence of Tulare County Clerk-Recorder staff.
- 2 Complete the Application and give all the information you have available to identify the record of marriage. If the information you have furnished is incomplete or inaccurate, it may be impossible to locate the record.
- ³ Submit \$17.00 for each certified copy requested. If no record of the confidential marriage is found, the \$17.00 fee will be retained for searching as required by Health and Safety Code Section 103650 and a Certificate of No Confidential Marriage Record will be issued.

PLEASE NOTE: If you are mailing your request, you will need to sign the sworn statement on the application and have a Certificate of Identity notarized by a Notary Public. Indicate the number of certified copies you are requesting and include your payment with this application, in the form of a personal check, postal or bank money order (International Money Order only for out-of-country requests), payable to:
