# Application for Confidential Marriage Record

Please read the instructions carefully before completing this application.

Please have your ID ready if you are submitting this form in person.

## Information:

Confidential Marriage records have been maintained in the Tulare County Clerk-Recorder's Office since 1972. Due to the confidentiality of these records, they can only be obtained by either party of the confidential marriage or by court order. (i.e. Ex-parte Application and Order for Release of Confidential Marriage License).

## Instructions:

- 1 If you submit your order in person, you must present a valid photo ID (government issued) and sign a sworn statement in the presence of Tulare County Clerk-Recorder staff.
- 2 Complete the Application and give all the information you have available to identify the record of marriage. If the information you have furnished is incomplete or inaccurate, it may be impossible to locate the record.
- 3 Submit \$17.00 for each certified copy requested. If no record of the confidential marriage is found, the \$17.00 fee will be retained for searching as required by Health and Safety Code Section 103650 and a Certificate of No Confidential Marriage Record will be issued.

PLEASE NOTE: If you are mailing your request, you will need to sign the sworn statement on the application and have a Certificate of Identity notarized by a Notary Public. Indicate the number of certified copies you are requesting and include your payment with this application, in the form of a personal check, postal or bank money order (International Money Order only for out-of-country requests), payable to:
