You **must** include your veterans' benefits received from the Veterans' Administration, even though it is non-taxable. If you **do not** include the VA benefits, you will receive the lower basic level of exemption, not the higher low-income level.

In accordance with Revenue and Taxation Code § 441(d)(1), persons shall make available for examination information or records regarding his or her property which the assessor considers relevant and essential to the proper discharge of the assessors' duties. Thus, the assessor may request additional information or documents to support the income reported on this worksheet (i.e., first page of IRS Form 1040, veterans' benefit statement, social security statement, etc.).
