**ASSESSMENT APPEALS BOARD**

This Board consists of five members. All five members attend monthly meetings rotating as a three member voting panel at each meeting. No member of the Board of Supervisors will serve on the Assessment Appeals Board. Eligibility Requirement: Has a minimum of five years professional experience in this State as a certified public accountant or public accountant, a licensed real estate broker, an attorney, a property appraiser accredited by a nationally recognized professional organization, or a property appraiser certified by the Office of Real Estate Appraisers.

Meets: The Board meets the Third Thursday of each month in the Board of Supervisors’ Chambers.

Function and Jurisdiction: To increase after giving notice or to lower upon application individual assessments in order to equalize assessments on the local tax assessment roll; to review, equalize, and adjust penal and escaped assessments on that roll except escaped assessments made pursuant to Revenue and Taxation Code Section 531.1; to exercise the powers specified in Section 1613 of the Revenue and Taxation Code.

## COUNTY PARKS ADVISORY COMMITTEE

This Committee consists of 5 Members of the public by the Board of Supervisors. Each supervisor shall nominate one member. The nominee need not reside in the district of the nominating supervisor, but must be a resident of Tulare County. These members shall be appointed for four year terms. The President of the Tulare County Historical Society. This position does not have a term. The President may name an alternate. The Parks Manager of Tulare County. This position does not have a term. The Parks Manager may name an alternate.

The Purpose of the Parks Advisory Committee (PAC) has been established by the Board of Supervisors to provide citizen input into matters of the County parks system, including funding, improvements, and maintenance. The PAC and its members will provide important citizen involvement and channel of public communication to the Board. PAC members will also assist the County in the promotion of park resources, features, and events within the community. As directed by the Board and supported by staff, the PAC will study issues, advise on subjects, and make recommendations and comments to the Board of Supervisors. The PAC shall have no authority to direct staff; staff will receive direction from the Board of Supervisors regarding the implementations of PAC recommendations.

The Duties of this Committee is to advise the Board of Supervisors on matters relating to the acquisition, development, maintenance and operation of parks in the County of Tulare. Provide recommendations to the Board of Supervisors regarding priorities and long term planning of Parks operations. Review the recreational program of the County in relation to the needs and desires of the citizens and make recommendations to the Board of Supervisors. As directed by the Board of Supervisors, conduct such investigations, studies and hearings which, in the judgment of the Board, will aid in effectuating the general purposes of the Board on matters pertaining to county parks.

Each of these members shall possess expertise in one or more of the following areas: auditing, finance or municipal finance, general business, planning, biology or environmental science, resource management or protection, wildlife management or protection, historic preservation, construction management, recreation management or planning.

## DEFINED CONTRIBUTION COMMITTEE

The Defined Contribution Committee meets the second Monday of the last month in each quarter at 1:00 p.m. and the third Monday in May for an Annual Investment Fund Review meeting.

Duties and responsibilities of the Committee are as follows: Review Ambulance Service Provider Agreement (Contract) compliance and performance; Consider and resolve disputes or grievances concerning the Contractor's performance or quality of patient care matters which may arise during the term of the Agreement. Approve the assessment of liquidated damages against the Contractor for infractions and/or failure to meet the standards set forth in the Agreement. Make recommendations to the County, Tulare County Department of Health, and the local EMS Agency regarding adjustments and/or modifications of the terms and conditions of the Agreement which govern Contractor's delivery of ambulance service; Receive regularly scheduled reports

regarding the Contractor's performance under the terms and conditions of the Agreement; To periodically submit reports to the Tulare County Board of Supervisors regarding its observations and recommendations of the Contractor's performance in Tulare County; and, To advise the Tulare County Board of Supervisors, the Tulare County Department of Health, and local EMS Agency on all matters relating to the Provider Agency Agreement performance. ### **KINGS/TULARE AREA AGENCY ON AGING ADVISORY COUNCIL**

Members require to serve on at least one committee of the Advisory Council and monitor at least one area of senior activity within his/her community. Attend Advisory Council and assigned committee meetings. Abstain from voting on any issue in which there may exist a conflict of interest with any organization with which they are currently involved. If any member is unclear as to what might constitute a conflict of interest, the matter shall be referred to the Parliamentarian or brought before the Council for a decision. Advisory Council members are obligated by law to file annual Conflict of Interest Statements (Form 700). If requesting reimbursement for authorized expenses related to Advisory Council membership, members must present all receipts for travel, food, parking and accommodations to staff in a timely manner, along with a completed volunteer claim form.

**TULARE COUNTY COUNCIL ON CHILD & YOUTH DEVELOPMENT**

The Child Care Planning Council approved the existing 35 member council to 25 members at their February 12, 2004 meeting. Membership shall consist of twenty percent of the membership shall be consumers, defined as a parent or person who receives, or who has received within the past 36 months, child care services, twenty percent of the membership shall be childcare providers, defined as a person who provides child care services or represents persons who provide child care services, twenty percent of the membership shall be public agency representatives, defined as a person who represents a city, county, city and county, or local education agency, twenty percent of the membership shall be community representatives, defined as a person who represents an agency or business that provides private funding for child care services, or who advocated for child care services through participation in civic or community-based organizations but is not a child care provider and does not present an agency that contracts with the CA Dept of Education to provide child care and development services, and the remaining twenty percent shall be appointed at the discretion of the appointing agencies. 13 members to be appointed by the Board of Supervisors and 12 members to be appointed by the Superintendent of Schools: two Members shall be Childcare Providers – a person who provides childcare services or

represents persons who provide childcare services, two Parents/Consumers – parent or person who receives, or who received within the past 36 months, childcare services, two Members shall be Community Representatives – a person who represents an agency or business that provides private funding for childcare services, or who advocates for childcare services through participation in civic or community-based organizations, but is not a childcare provider and does not represent an agency that contracts with State Department of Education to provide childcare and development services, three Public Agency Representatives – a person who represents a city, county or local education agency, and three At-Large members – appointed from any of the above categories or outside of these categories at the discretion of the appointing agencies.

Function: shall provide a forum for the identification of local priorities for childcare and the development of policies to meet the needs identified within those priorities.

One (1) member from a category which may include one of the following shall be selected to represent partners from the community: Mental Health practitioner or representative, Health practitioner, health clinic, hospital, or other medical service agency, a Senior citizen or agency providing services primarily to senior citizens, a Community-based organization, a Community health-related coalition, and a Current or Formerly Homeless community representative.

The responsibilities of the Task Force shall include: Assist the Agency in assessing the Community's homeless population and services, including strengths and gaps in the current system (including rural and/or underserved areas) and help to develop strategies to meet unmet needs. Recommend policies that improve quality of life for homeless persons. Make recommendations on strategies, goals, and funding resources to address homelessness within the County. Encourage support for the development and implementation of effective homes programs and services. Develop recommendations for the Agency relevant to existing and proposed legislation on

homelessness. Assist in the production of written reports for presentation to the Board of Supervisors. Present an annual report to the Board of Supervisors. With the concurrence of the Board of Supervisors, advocate for increased action to improve the situation of homeless persons. Such other duties as assigned by the Board of Supervisors or Health & Human Services Agency Director.

This Board consists of Directors as follows: (1) Elected member of governing body of each Member entity, (2) Representatives of mutual water company or water corporation regulated by the Public Utilities Commission as defined in Water Code Section 10723.6(b), servicing an area within the Authority's jurisdiction, nominated by their respective governing body, and appointed by the Board of Directors, (1) Representative from an landowner and groundwater user in a "white area," appointed by the County, (1) At Large Representative nominated and appointed by the Board of Directors.

Each of the Member is a local government entity with either water supply, water management, or land use responsibilities within the Subbasin and is qualified individually to serve as a GSA under the provisions of SGMA. Responsible for assuming its regulatory role and for submitting a Groundwater Sustainability Plan to the Department of Water Resources. Member to begin collecting and organizing data, engaging and retaining experts and consultants, and soliciting feedback from beneficial users, users of groundwater and interested parties within the portion of the Subbasin subject to their jurisdiction, for the purpose of preparing a GSP and for the purpose of negotiating Coordination Agreements with the other GSAs in the Subbasin.

## **FIRST 5 TULARE COUNTY**

This Board will consist of seven members as follows: (2) Members of Tulare County Health and Human Services Agency, (1) Member of Tulare County Board of Supervisors, (1) Member that is the Tulare County Superintendent of Schools or Designee, (1) Member from one of the following categories: Persons responsible for management of children’s services, public health services, behavioral health services, social services, and tobacco and other substance abuse prevention and treatment, Recipients of project services included in the county strategic plan, Educators specializing in early childhood development, Representative of a local child care resources or referral agency or a local child care coordinating group, Representatives of local organization for prevention or early intervention for families at risk, Representatives of community-base organizations that have the goal of promoting nurturing and early childhood development, Representatives of local school districts, Representatives of local medical, pediatric, or obstetric associations or societies.

The duties of this board are to adopt an adequate and complete County Strategic Plan for the support and improvement of early childhood development within the County consistent with Health and Safety code Section 130140(A)(C)(D)&(E). Hold at least one public hearing on the Commission's Proposed Strategic Plan prior to the adoption of the plan. Review the County Strategic Plan on at least an annual basis, and revise such plan as necessary or appropriate. Measure the outcomes of county funded programs through the use of applicable, reliable indicators and review that information on a periodic basis as part of the public review of the county strategic plan. Hold at least one public hearing on the Commission's Periodic Reviews of the County Strategic Plan and prior to adoption of any revisions to said plan. Submit its adopted County Strategic Plan and any revisions to the Board for approval prior to submission to the State Commission. Conduct an audit on or before October 15 of each year; conduct at least one public hearing prior to adopting any annual audit and report; issue a written report on the implementation and performance of its functions during the preceding fiscal year, including the manner in which funds were expended; the progress toward and the achievement of program goals and objectives; and the measurement of specific outcomes through appropriate reliable indicators. The written report required by this section shall be transmitted to the State Commission, and the Tulare County Commission shall make copies of its annual audits and reports available to members of the general public on request at no cost. Establish one or more advisory committees to provide technical and professional expertise and support for any purposes that will be beneficial in accomplishing the purposes of the Act and shall cause such advisory committees to make recommendations and reports as deemed necessary or appropriate. Submit a budget to the Board for adoption. The Board will adopt the Budget and the Commission shall retain authority of expenditures.

## **SAN JOAQUIN VALLEY RAIL COMMITTEE**

Regular Members must be a resident of the county they represent and cannot be an elected official. Regular Members cannot be staff of SJJPA Member Agencies or SJJPA staff. SJJPA may select up to (4) additional Regular Members who reside in counties outside of the those counties listed above that are served by San Joaquin Thruway bus services and/or represent areas that could be served by future extension of the San Joaquin.

The Committee shall meet regularly to discuss and formulate plans, suggestions, and ideas for changes and improvements to passenger train service in the San Joaquin Rail Corridor and then pass o to the San Joaquin Joint Powers Authority; the Committee's generally agreed upon proposals for their consideration.

## **TULARE COUNTY ASSOCIATION OF GOVERNMENTS**

This Board shall consist of (5) Members of the Board of Supervisors (Tenure) with Alternates, (1) Councilman from each City appointed by the City Councils of such respective cities (Tenure), (3) Residents of the County to be appointed by a majority vote of the other members of the governing Board. Alternates may be appointed for any or all members of the Board of Supervisors. They must be a resident of the Supervisorial District in the County. Such alternates shall participate as a member of the governing board only when the principal member is absent.

Duties include: review, evaluate and coordinate applications for planning, transportation, and air quality maintenance programs, or development proposals of area-wide significance utilizing either, Federal, State or local public sources of funding. Assist political subdivisions located in Tulare County in obtaining various forms of governmental assistance by providing advice, counsel and professional direction. Designate an appropriate system or area-wide comprehensive planning, transportation and air quality maintenance program goals and objectives. Prepare or direct the preparation of necessary plans and studies consistent with the comprehensive planning, transportation and air quality maintenance program goals and objectives. Promote public interest in and an understanding of the comprehensive planning, transportation and air quality maintenance program processes within Tulare County. Serve as a center for disseminating general planning, transportation and air quality maintenance program information of area-wide significance to the various local jurisdictions. Investigate and prepare recommendations regarding the resolution of conflicts or other circumstances arising from the multiplicity of jurisdictions concerned with comprehensive development. Prepare a budget and work program each year, demonstrating ability to implement above goals. Serve as the mechanism for the distribution of State and Federal funds which are allocated to local and area-wide entities on an area-wide basis as provided for in State and Federal law or regulation.

## TREASURY OVERSIGHT COMMITTEE

This Committee consists of five members who serve at the pleasure of the Board as follows: The Auditor-Controller; A representative appointed by the Board of Supervisors; The County Superintendent of Schools or his Designee; A representative selected by a majority of the presiding officers of the governing bodies of the school districts and community college districts in the County; A representative selected by a majority of the presiding officers of the legislative bodies of the special districts in the County that are required or authorized to deposit funds in the County Treasury. And, two members of the Public with term endings as follows: One with expertise or an academic background in public finance, the other, according to SB 866, economically diverse and bipartisan in political registration.

Investment Policy: In accordance with Government Code Section 27133, the County Treasurer shall annually prepare a County Treasurer's Investment Policy that will be reviewed and monitored by the County Treasury Oversight Committee.

Audit of Compliance: In accordance with Government Code Section 27134, the Tulare County Treasury Oversight Committee shall cause an annual audit to be conducted to determine the county treasury's compliance with Article 6 of Chapter 5 of Division 2 of Title 3 of the California Government Code. The audit may include issues relating to the structure of the investment portfolio and risk.

## UPPER KINGS BASIN INTEGRATED REGIONAL WATER MANAGEMENT

Consists of representatives of the Members and representatives of the interested parties. Each Member and each Interested Party may appoint one member to the Advisory Committee. Each Member and each Interested Party may appoint at least one alternate to the Advisory Committee. Members and alternates shall be designated in writing from time to time by the respective governing body of each appointing entity. The Advisory Committee shall provide advice to the Board, but shall have no authority to take action.

Purpose is to coordinate all activities necessary to maintain, modify, amend and implement the IRWMP in accordance with the Act; to screen and select projects for grants applications; to prepare and submit grant applications on behalf of the Members; to assist Members in the development of water management projects; to participate in water management projects; to allocate and manage grant funding; to create and appoint committees and sub-committees; to undertake, on behalf of the Members, all

actions required by the California Department of Water Resources and the State of Water Resources Control Board related to the IRWMP; to make and enter into contracts and agreements; to sue and be sued in its own name; to operate any buildings, works, or improvements; to acquire by eminent domain, or otherwise, and to hold or dispose of any property, to issue bonds and other forms of indebtedness, to the extent and on the terms provided by law for any of the parties. To incur debts, liabilities and obligations as approved by the Board of Directors.
