WHEREAS, pursuant to the provisions of Government Code § 87300 et seq. every government agency, as defined in § 82041, is required to adopt and maintain a Conflict of Interest Code; and

WHEREAS, Government Code § 87306 requires that Conflict of Interest Codes shall be amended when change is necessitated by changed circumstances within the agency; and,

WHEREAS, this Board is the code reviewing body for those local government agencies, except cities, situated totally within the County; and,

WHEREAS, the amendments to the Codes submitted appear to be in order and should be approved; and,

WHEREAS, the proposed Conflict of Interest Code also appears to be in order and should be approved;

NOW, THEREFORE, IT IS HEREBY RESOLVED by this Board as follows:

1. The amendments to the Conflict of Interest Codes of the local government agencies in the County of Tulare that are described in the attached Exhibit "A" have been reviewed and are approved as submitted.

2. The Conflict of Interest Code of the local agency in Tulare County that is described in the attached Exhibit "A" has been reviewed and is approved as submitted.
