8 Section 87300 et seq., every local government agency, as defined
9 in Section 82041, is required to adopt a Conflict of Interest
10 Code; and

11 WHEREAS, various local agencies within the County of Tulare
12 have adopted Conflict of Interest Codes and forwarded them to
13 said Board for consideration; and

14 WHEREAS, said Conflict of Interest Codes appear to be in
15 order and should be approved as submitted;

16 NOW, THEREFORE, IT IS HEREBY RESOLVED by this Board as
17 follows:

18 1. The Conflict of Interest Codes of the local agencies
19 in the County of Tulare that are described in the attached
20 Exhibit "A" have been reviewed by this Board and are approved as
21 submitted.

22 2. The Clerk of this Board is directed to return to the
23 foregoing agencies an approved copy of the Conflict of Interest
24 Code, together with a notification relative to the date upon
25 which such code was approved.

26 3. As the Conflict of Interest Codes for various local
27 agencies in the County of Tulare were not available for review
28 at this time in final acceptable form, the review of such Codes
29 shall be continued from week to week until the Codes of such
30 agencies have been considered and acted upon by this Board.
