WHEREAS, in an effort to achieve uniformity throughout the State, the FPPC has encouraged adoption of such Code by reference; and

WHEREAS, various local agencies within the County of Tulare have adopted the Code by reference, either on a replacement basis or as an additional adoption, and have forwarded them to this Board for consideration; and

WHEREAS, said Conflict of Interest Codes appear to be in order and should be approved as submitted;

NOW, THEREFORE, IT IS HEREBY RESOLVED by this Board as follows:

- 1. The Conflict of Interest Codes of the local agencies in the County of Tulare that are described in the attached Exhibit "A" have been reviewed by this Board and are approved as submitted.
- 2. The Clerk of this Board is directed to return to the foregoing agencies an approved copy of the Conflict of Interest Code, together with a notification relative to the date upon

which such Code was approved.

3. As the Conflict of Interst Codes for various local agencies in the County of Tulare were not available for review at this time in final acceptable form, the review of such Codes shall be continued from week to week until the Codes of such agencies have been considered and acted upon by this Board.
