7 WHEREAS, pursuant to the provisions of Government Code
8 Section 87300 et seq., every local government agency, as defined
9 in Section 82041, is required to adopt a Conflict of Interest
10 Code; and

11 WHEREAS, the Fair Political Practices Commission (FPPC) has
12 adopted, pursuant to 2 Cal. Admin. Code section 18730, a uniform
13 Conflict of Interest Code that may be adopted by individual
14 agencies by reference; and

15 WHEREAS, in an effort to achieve uniformity throughout the
16 State, the FPPC has encouraged adoption of such Code by reference;
17 and

18 WHEREAS, various local agencies within the County of Tulare
19 have adopted the Code by reference, either on a replacement basis
20 or as an additional adoption, and have forwarded them to this
21 Board for consideration; and

22 WHEREAS, said Conflict of Interest Codes appear to be in
23 order and should be approved as submitted;

24 NOW, THEREFORE, IT IS HEREBY RESOLVED by this Board as
25 follows:

26 1. The Conflict of Interest Codes of the local agencies
27 in the County of Tulare that are described in the attached
28 Exhibit "A" have been reviewed by this Board and are approved as
29 submitted.

30 2. The Clerk of this Board is directed to return to the
31 foregoing agencies an approved copy of the Conflict of Interest
32 Code, together with a notification relative to the date upon

1 which such Code was approved.

2 3. As the Conflict of Interest Codes for various local
3 agencies in the County of Tulare were not available for review
4 at this time in final acceptable form, the review of such Codes
5 shall be continued from week to week until the Codes of such
6 agencies have been considered and acted upon by this Board.

7 The foregoing Resolution was adopted upon motion of
8 Supervisor Gould , seconded by Supervisor Mangine ,
9 at a regular meeting of the Board of Supervisors of the County
10 of Tulare held on April 28, 1981, by the following vote:
