



Conflict of Interest Code for Woodlake Public Cemetery District

The Political Reform Act (Government Code Section 81000, et seq.) requires state and local government agencies to adopt and promulgate Conflict of Interest Codes. The Fair Political Practices Commission has adopted a regulation (2 California Code of Regulations Section 18730) that contains the terms of a standard Conflict of Interest Code, and may be incorporated by reference in an agency's code. After public notice and hearing, the standard code may be amended by the Fair Political Practices Commission to conform to amendments in the Political Reform Act. Therefore, the terms of 2 California Code of Regulations Section 18730 and any amendments to it duly adopted by the Fair Political Practices Commission are hereby incorporated by reference. **This regulation and the attached appendices designating positions and establishing disclosure requirements shall constitute the Conflict of Interest Code for the Woodlake Public Cemetery District.**

The Form 700s for designated positions, such as the Board of Directors and District Manager, shall be filed directly with the Clerk of the Board for the Tulare County Board of Supervisors. The District shall retain a copy of all filed Form 700s, and shall make the forms available for public review, inspection and reproduction (Government Code Section 81008).

The provisions of all Conflict of Interest Codes and amendments previously adopted by the District are hereby superseded.

*Consultants shall be included in the list of designated positions and shall disclose pursuant to the disclosure requirements in the code subject to the following limitation:

The District Manager may determine in writing that a particular consultant, although a "designated position," is hired to perform a range of duties limited in scope and therefore is not required to comply fully with the disclosure requirements in this section. Such written determination shall include a description of the consultant's duties, and based upon that description, a statement of the extent of disclosure requirements. The District Manager's determination is a public record and shall be retained for public inspection in the same manner and location as this Conflict of Interest Code (Government Code Section 81008).

Appendix B: Disclosure Categories

Disclosure Category 1: Full Disclosure

All interests in real property located entirely or partly within this District's jurisdiction or boundaries, or within two miles of this District's jurisdiction or boundaries or of any land owned or used by this District. Such interests shall include any leasehold, ownership interest or option to acquire such interest in real property. All investments, business positions, ownership and sources of income, including gifts, loans and travel payments.

Disclosure Category 2: Full Disclosure (excluding interests in real property)

All investments, business positions, ownership and sources of income, including gifts, loans and travel payments.

Disclosure Category 3: Interests in Real Property (only)

All interests in real property located entirely or partly within this District's jurisdiction or boundaries, or within two miles of this District's jurisdiction or boundaries or of any land owned or used by this District. Such interests include any leasehold, ownership, interest or option to acquire such interest in real property.

Disclosure Category 4: General Contracting

All investments, business positions, ownership and sources of income, including gifts, loans and travel payments, from sources that provide or have provided in the last two years, leased facilities, goods, supplies, materials, equipment, vehicles, machinery, services, or the like, including training or consulting services, of the type utilized by the District.

Disclosure Category 5: Regulatory, Permit or Licensing Duties

All investments, business positions, ownership and sources of income, including gifts, loans and travel payments, from sources that are subject to the regulatory, permit or licensing authority of, or have an application for a license or permit pending before this District.

Disclosure Category 6: Grant/Service Providers/Agencies that Oversee Programs

All investments, business positions, ownership and sources of income, including gifts, loans and travel payments, or income from a nonprofit organization, if the source is of the type to receive grants or other monies from or through this District.
