SAFETY TIPS

- Pets are curious. They may bump into, turn on, or knock over cooking equipment. Keep pets away from stoves and countertops.
- Keep pets away from candles, lamps, and space heaters
- Always use a metal or heat-tempered glass screen on a fireplace and keep it in place.
- Keep pets away from a chimney's outside vents.
 Have a "pet-free zone" of at least 3 feet (1 meter) away from the fireplace. Glass doors and screens can stay dangerously hot for several hours after the fire goes out.
- Consider battery-operated, flameless candles.
 They can look and smell like real candles.
- Some pets are chewers. Watch pets to make sure they don't chew through electrical cords. Have any problems checked by a professional.

SMOKE ALARMS

- Have working smoke alarms on every level of the home. Test your smoke alarms at least once a month.
- If the smoke alarm sounds, get out and stay out.
- Never go back inside for pets in a fire. Tell firefighters if your pet is trapped.

Pets and Wildfires

Make sure pets are included in your family's wildfire evacuation plan. Build an evacuation kit for each pet in your household. Ensure each kit is a size and weight that can be quickly and easily loaded into a vehicle when packing to evacuate.



FACT

Pets or wild animals have a part in starting about 750 home fires per year. These involve cooking equipment, fireplaces and chimneys, space heaters, lamps, bulbs, wiring, and candles.





AGRICULTURAL PEST MANAGEMENT SPECIALIST

It was about 5 years ago when I talked to you last about our new Agricultural Pest Management Specialist and his name was Dennis Haines. In fact, this was a new title for an old position, most known as staff biologist. Dennis was no newcomer to the job as he had 40 years of service to the County at that time and then he put in another 5 years before he retired not too long ago. He will be missed but he did have a little time to work with our newest hire, Alex Mendenhall.

Our Agricultural Pest Management Specialist does a variety of tasks, spending much of his time speaking to the public and community businesses about pests they are dealing with. Homeowners may want to know about the bugs that come in every spring and local Pest Control Businesses may need to know more about a specific pest so they can tailor their treatment plan to that pest. If he isn't doing those things, he is probably identifying a pest that one of our Inspectors found on an export shipment. We are required to certify loads of fruit and other commodities free from certain pests, so we need to have them identified correctly. This is a very important benefit to our local agricultural shippers because they would otherwise have to wait for their results from CDFA up in Sacramento.

I could go on and on about this person's responsibilities, but I wanted to be sure and save enough time to introduce our newest specialist. He has been doing a great job for us and the industry too so please stop in and say hi to him the next time you are in Tulare.

Alex Mendenhall, Agricultural Pest Management **Specialist:** I was born and raised in Utah and moved to the central valley in the fall of 2011. I quickly enrolled in classes at College of the Sequoias, where I discovered my love for plants and insects. I graduated in 2016 with two associate degrees: in Ornamental Horticulture and Landscape Management. From there I went on to California State University Fresno, I graduated in 2019 with a bachelor's degree in plant science. After graduating I worked for Monrovia Nursery Company in propagation and research. I also worked for the University of California at Lindcove, specializing in citrus entomology. I started with the Tulare County Agricultural Commissioner/Sealers Office in the fall of 2023. Since then, I have continued to expand my knowledge of insects and the various programs and activities within the county.

STEP UP YOUTH CHALLENGE

The Tulare County Health & Human Services Agency is honored to manage the Step-Up programs and to provide a variety of services to help all at-risk youth in Tulare County. If you would like to be a part of making a difference for our youth, please visit FriendsofTulareCounty.org to donate.

Step Up is a consortium of programs and partnerships that are united by the shared goal of improving outcomes for youth in Tulare County. The consortium was created by the Tulare County Board of Supervisors in 2008. Initially begun as a Gang Prevention initiative, it has evolved to encompass all at-risk youth in Tulare County.

STEP UP PROGRAMS

Since its inception, Step Up has created six different programs, including:

- #LEAD Leadership and College readiness program serving high school juniors and seniors.
- #GROW Leadership and Civic Engagement program serving high school freshmen and sophomores.
- Youth Commission The program makes recommendations to the Board of Supervisors regarding the Step Up Youth Activities Grant. This is a grant that provides financial support for nonprofit organizations that work with underserved areas in the county. The grant ranges between \$5,000 and \$10,000 per supervisorial district.
- Summer Night Lights Provides funding to community organizations up to \$1,000 per event to host positive events such as swim nights, resource fairs, movie nights, etc., during the summer months.
- Youth Challenge The program is contracted to TCOE to challenge students in high school and middle school in coordinating a community service project.
- Loop Bus Provides free transportation to free activities for at-risk youth around Tulare County.

HEAT ILLNESS



With our recent precipitation, it may seem like the warm weather is far away, but it is right around the corner. Sunlight is warm, inviting, and linked to positive emotional health, preventing Vitamin D deficiency and Seasonal Affective Disorder (SAD). Without it, Earth would not be able to sustain life. With the benefits of sunshine come its safety concerns as well. UV rays can harm the body, and the intense valley heat can place additional stress on the body during the summer. Avoiding the sunlight isn't always voluntary, so

take these safety precautions when working in high-heat situations.

- **Heat Illness Safety Training**. If you work outdoors during high-heat situations, your department will provide proper training to prevent heat illness.
- **Plan. Get acclimated.** If you are new to working in the heat, start slowly to get your body used to the heat. Check the weather ahead of time to know when heat waves are approaching. Plan your outdoor work early to avoid peak heat times. Do not drink alcohol before working in the heat.
- **Be Proactive.** Drink cool, fresh water, 8 ounces every 15 minutes during the work shift. Do not wait until you are thirsty to start drinking water. Choose water over soft drinks. Rest under shade to cool down.
- **Know the Symptoms.** You know when the weather is hot, but how do you know when **YOU** are too hot? Fatigue, heavy sweating, headache, cramps, dizziness, high pulse rate, and nausea/vomiting are all early symptoms of heat illness and require intervention. Life-threatening symptoms include high body temperature, red/hot/dry skin, confusion, convulsions, and fainting.

With the proper precautions, summer can be an enjoyable time. Beat the heat by reviewing your Heat Illness Prevention Plan, planning, being proactive, and knowing the symptoms of heat-related illnesses.
