Welcome to the Tulare County Board of Supervisors' Website

Few of us could have imagined the ways the pandemic has changed lives and livelihoods and affected businesses in every community. Many continue to struggle with fear, loneliness, the loss of loved ones, unemployment, anxiety, and the loss of businesses.

Vaccinations have been extensively studied in rigorous clinical trials and the distribution of safe and effective vaccines gives us a sense of hope for the future.

The County receives an allotment of Pfizer and Moderna COVID-19 vaccines from the state. Our public health branch, along with community partners, are currently vaccinating healthcare personnel, those over 65 years of age, and those at risk of exposure at work in the sectors of education and childcare, emergency services and first responders, and food and agriculture. The Johnson & Johnson one-shot vaccine has been approved by the FDA and we'll soon see that option in Tulare County.

Though vaccines are in short supply right now, we hope that federal efforts to bolster production will mean greater allotments in the future. The State increased the vaccination allotment for Tulare County the first week of March by 114% and by 40% this week (March 8).
