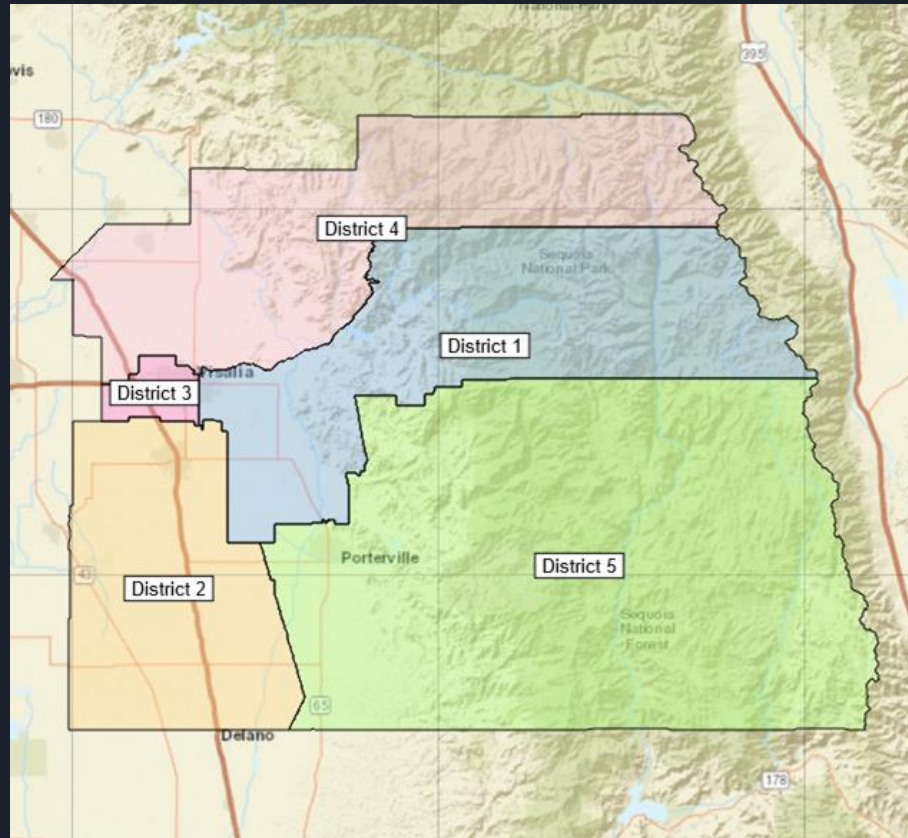




# Focus Points on Creating Proper Equitable Maps

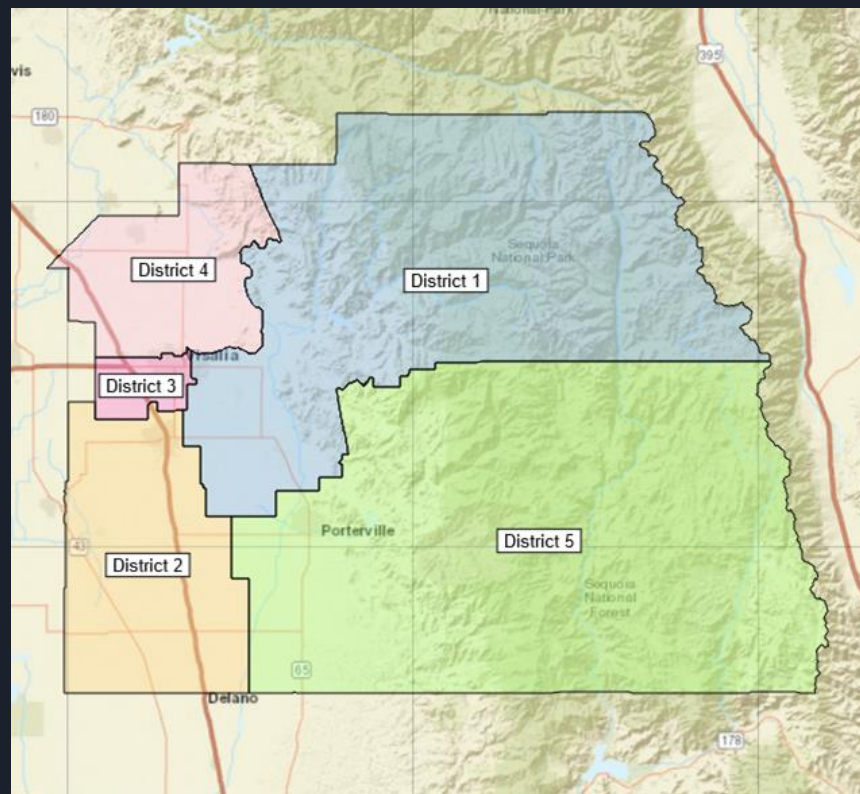
- Balance all district populations to near zero deviation
- Ensure districts are drawn with compactness and contiguity
- Geographic Landmarks as district edges
- Keep communities together as much as possible
- Consider cross-community interaction
- Consider areas in which a community commutes and works.
- Never consider political parties or candidates as a factor.





Current Board of Supervisors Map

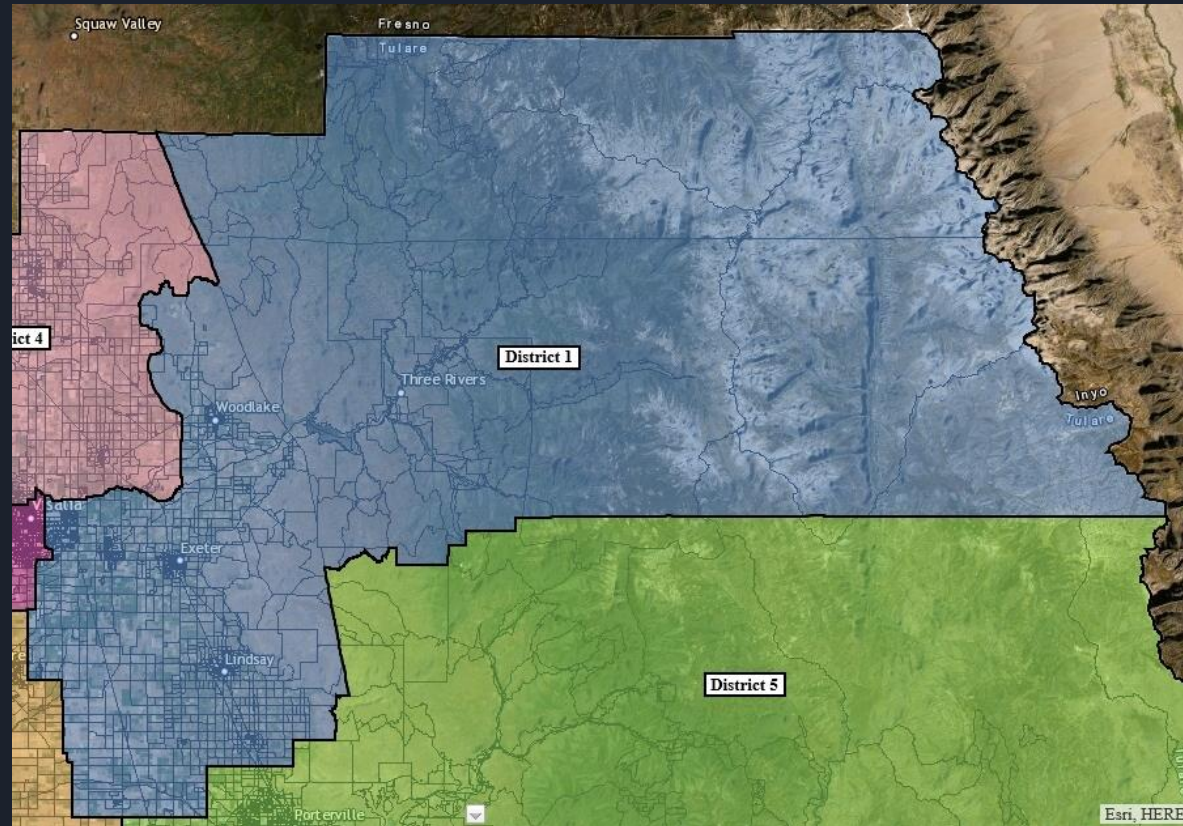




Proposed Board of Supervisors Map

# Summary

- Each district adjusts for the current population totals, providing equal representation
- Communities are kept together
- Tulare and Porterville are kept together
- The mountain range is two districts, properly accounts for the geographically prohibitive nature between the two being considered one.
- One mountain district requires Tulare and Porterville to be split.
- District edges are easily distinguishable.
- 3 districts are latino CVAP majority. Close to being 4 districts. Current county CVAP total is just over 51%

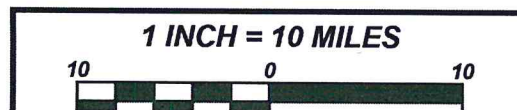
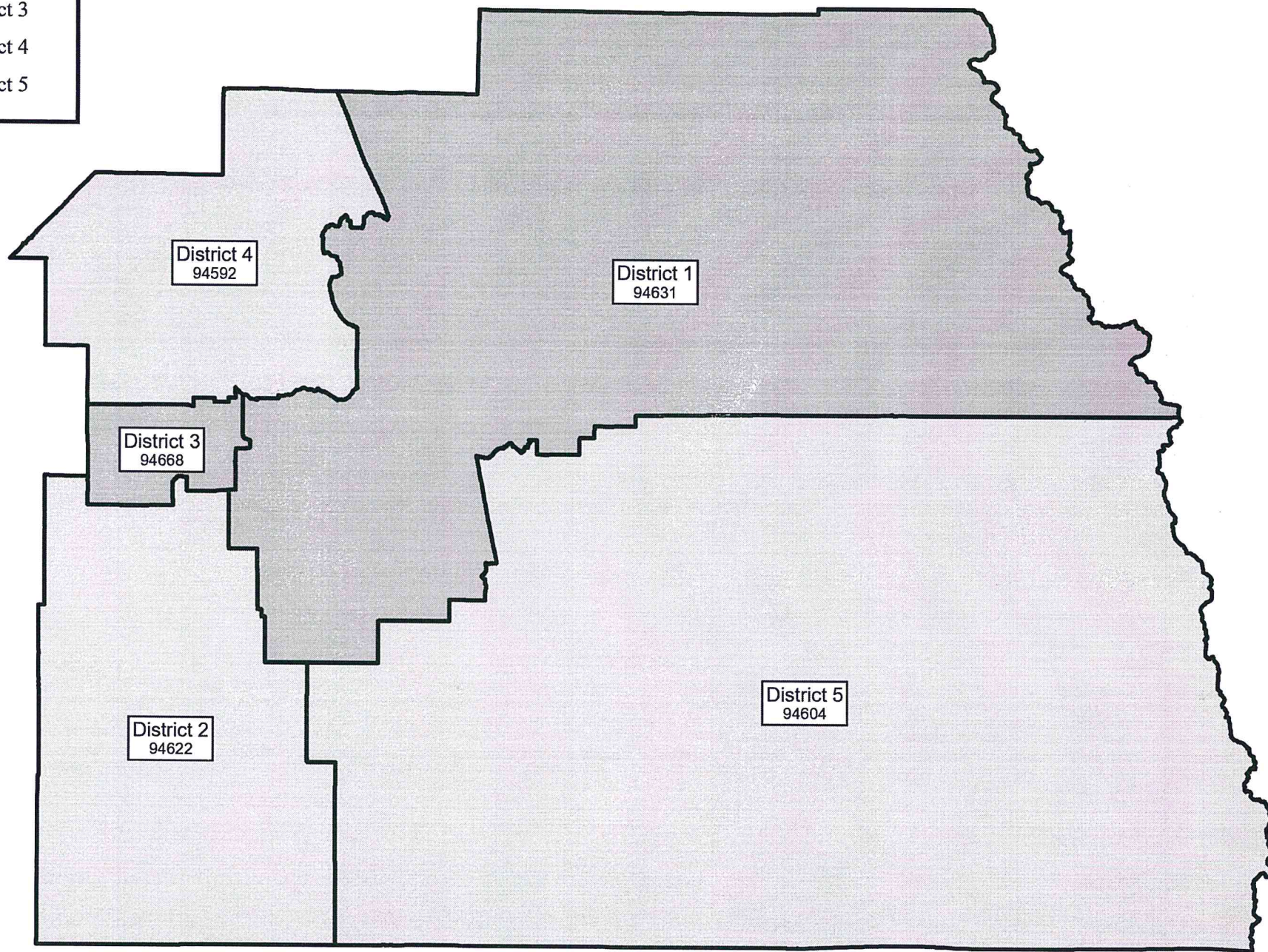
