



2021 COUNTY OF TULARE SUPERVISORIAL REDISTRICTING

TENTATIVE TIMELINE

Revised June 16, 2021

Items in **bold** reflect legal requirements.¹
Italicized items are subject to change depending on actions of others.

DATE	ACTION
2020	BOS approves creation of advisory commission on redistricting.
2020	Outreach consultant for non-English-speaking communities hired.
2020-2021	Staff, consultant publicize commission, encourage applications from members of all communities.
April 1, 2021	Legal deadline for federal government to release census data to states. <i>(Not met due to COVID-19 pandemic.)</i>
April 30, 2021	Deadline for applications for advisory commission.
May 11, 2021	BOS appoints members of advisory commission.
May 2021	Advisory commission holds first meetings – get-acquainted, organizational, training, set meeting schedule, etc.
Summer-Fall 2021	Advisory commission meets to determine if supervisorial boundaries need to be changed. Any hearings by commission after draft maps drawn do not count toward official hearings on draft maps.
<i>August 16, 2021</i>	<i>Estimated date for actual release of census data to states.</i>
<i>August 23, 2021</i>	<i>Estimated date for release of unmodified census data by state to local agencies.</i>
<i>September 23, 2021</i>	<i>Estimated date for release of final adjusted census data by state, after modifications to move state prisoners from location of prison to domicile immediately before most recent term of incarceration.</i>

DATE	ACTION
October 7, 2021	About two weeks after receipt of info from state. GIS staff completes construction of final countywide database by year 2020 census block using modified state info and releases to public.
September-October 2021	Commission prepares draft maps.
October 2021	BOS may not delegate hearings on draft maps. BOS holds hearings on draft maps.
October-November 2021	BOS approves final map and directs staff to bring ordinance to adopt final boundaries.
November 16, 2021	Introduction of ordinance setting new boundaries.
November 23 and 30, 2021	BOS dark dates.
December 7 or 14, 2021	Adoption of ordinance setting new boundaries.
December 14, 2021	Last regular BOS meeting before legal deadline.
December 15, 2021	Legal deadline for BOS to adopt ordinance.
December 16, 2021	Normal first date for candidates to begin collecting signatures in lieu of filing fees.
January 11, 2022	If ordinance not adopted until Dec. 14, first date for candidates to begin collecting signatures in lieu of filing fees (no. of signatures reduced proportionately).
February 9, 2022	Last date to file petition in lieu of filing fees.
February 14, 2022	First date to file declaration of candidacy.
March 11, 2022	Last date to file declaration of candidacy (regular date).
March 16, 2022	Last date to file declaration of candidacy (extension if incumbent did not file.)
June 7, 2022	Primary election
December 2031	Web page regarding 2021 redistricting must be maintained until 10 years after final map adopted.
