The application form for a Partial Non-Renewal of a Williamson Act Contract /Agricultural Preserve must be filled out completely and in every respect with <u>all</u> questions answered and <u>all</u> required attachments before the County can officially accept the application for filing. In the course of accepting and processing the application, the Permit Center Official or Chief Planner may ask the applicant to clarify, correct or otherwise supplement the required information. The application may be filed with the Resource Management Agency Permit Center, at 5961 S. Mooney Blvd., Visalia CA 93277. Phone is (559) 624-7000.

1. Ordinance No. 352, as amended, requires a filing fee to be paid at the time of filing an application. This fee is to cover the cost to the County for advertising, investigations and processing the application through its various stages

2. Due to California's State budget crisis, Tulare County Board of Supervisors adopted Resolution No. 2009-0091 on February 10, 2009, which established new policies regarding amendments to existing Williamson Act Contracts. If the State fails to pay subvention funds off-setting property tax loss required by the Open Space Subvention Act, the Board has the authority to unilaterally declare the contract terminated as null and void.
