The Public Works Branch of the Resource Management Agency (RMA) respectfully submits the following report to you to document the progress in the branch for the month of August 2019.

### AUGUST WAS A MONTH OF CONSTRUCTION PROJECT CELEBRATIONS

AVENUE 280 WIDENING PROJECT



On August 6<sup>th</sup> the County celebrated the Avenue 280 Widening Project, a partnership with the City of Visalia, Tulare County Association of Governments and Caltrans. This project widened and improved Avenue 280 (also known as Caldwell Avenue) by designing and constructing approximately 2-miles of four-lane roadway with treated median and/or median lane. The project also includes buffered bike lanes, a multi-use trail, and drainage pipeline. The project limits are between State Route 99 and Akers Street. This widening project improves safety, provides for alternative modes of transportation (i.e. bicycles, pedestrians), improves the level of service along the corridor, and improves regional access to State Route 99. The project represents a

portion of the ultimate plan to improve the 13-mile stretch of Avenue 280, Caldwell Avenue, and Visalia Road that extends through the cities of Visalia, Farmersville and Exeter. Staff is working with Cal Valley Construction to submit final paperwork in preparation for closing out and taking the project to the Board for final acceptance.

#### ALLENSWORTH SCHOOL SIDEWALK RIBBON CUTTING

On August 26<sup>th</sup> a Ribbon Cutting Celebration was held at the Allensworth Elementary School to commemorate this Safe Routes to School Project. This project constructed approximately 640 linear feet of sidewalk in front of Allensworth Elementary School and around the local community center. This project included curb and gutter, asphalt paveouts, pavement markings, striping and ADA ramps. This project was funded though the 2017 Active Transportation Program Augmentation. Funds for this program were made available through Senate Bill 1. This project provides a safer pedestrian facility on both sides of Young Road (Road 81). The Ribbon Cutting ceremony was attended by approximately 60 Allensworth Elementary School students.



In addition to the Ribbon Cutting Ceremony, County staff continued to work with DOD Construction to submit final paperwork to submit to the Board of Supervisors for formal acceptance before the end of October.






#### SAFETY:

### MANAGEMENT GROUP 2:

#### **BRIDGE PROJECTS**

Construction of the M220 Bear Creek Road Bridge over Rancheria Creek moved quickly during the month of August. Contractor Agee Construction formed and cast abutment pilasters, placed all Stage 2 falsework, formed the bridge deck including placement of all reinforcing steel, post-tensioning ducts and deck voids, cast the Stage 2 bridge deck/superstructure, performed post-tensioning and formed/cast all bridge posttensioning closure pours and backwalls. In September, the contractor is expected to form/cast Stage 2 barrier rail, backfill behind abutments and place all roadways fills and asphalt.

At the current pace, bridge construction will finish by the end of October.



During the month of August, initial environmental analysis and development of studies (traffic, hazardous waste, water quality, hydraulic, biological resources, wetlands, historic resources, land use/community impacts, farmlands and cultural resources), continued on the following projects:

Design consultants continue to work on the following projects:

During the month of August, consultants continued moving forward with the environmental and preliminary engineering phases of the eight projects listed above.

#### **ROAD CONSTRUCTION PROJECTS**

#### SAFETY AND COMMUNITY IMPROVEMENT PROJECTS:

**2017 Community Improvement Project - Phase 3:** The project is scheduled to be taken to the Board for formal acceptance on September 10<sup>th</sup>.

**Traver Jacob Street Improvements**: As part of the August 20<sup>th</sup> BOS meeting, the project was awarded to R.J. Berry Jr., Inc. of Selma, CA. Upon award of the project, County staff scheduled a pre-construction meeting for the first week of September. It is anticipated that work on the project will begin by the middle of September.

**Woodville Sidewalk Improvement**: DOD Construction continued to make good progress in August. The majority of the concrete work on the east west side of Road 168 was complete between the southern project boundary (Woodville Elementary School) and Road 167 in August. The work adjacent to Woodville Elementary was completed by the second week of August having little impact on the start of school. The contractor also completed the majority of the concrete work along the east side of the project between the southern project boundary and Road 168. CSET was on site beginning August 30<sup>th</sup> to place the sidewalk on the east side of Road 168 and anticipates completion of their portion of the work by Sept. 13<sup>th</sup>. It is anticipated that all work on the project will be complete before the end of September.

**Worth Drive (M146) Safety Improvement Project**: The Contractor will begin work on September 3<sup>rd</sup> and should be completed by the end of the month.

**Earlimart Park Improvement Project**: Bid proposals were opened on August 15<sup>th</sup>, and a total of six (6) bids were received. The lowest bid in the amount of \$483,990.60 was submitted by American Paving Co. from Fresno, CA. The construction contract award is scheduled for the BOS meeting of September 10<sup>th</sup>.

**Pixley Main St. Sidewalk Improvement Project**: Project bid proposals were received and opened at the BOS on August 20<sup>th</sup>. A total of eight (8) bids were received. The lowest base bid, in the amount of \$1,200,971.52, was submitted by JT2 dba Todd Companies of Visalia, CA. The construction contract award is pending due to a matter concerning a closed session with the Board of Supervisors.

**Alpaugh Center Street Improvements Project**: The project is progressing to the 65% benchmark. Exploration at the proposed basin site was completed.

Avenue 144 & Road 96 Safety Improvements Project: This project includes the conversion of a two-way stop-controlled single lane rural roundabout. Initial utility coordination efforts are underway. Thirty-percent (30%) plans is the next milestones for this project.

**Community Accessibility Enhancement Project**: Since the first official working day of July 29<sup>th</sup>, the contractor MAC General Engineering has completed all work in the community of Orosi and is nearing completion of the work in Poplar and Strathmore. To date the contractor has completed all concrete improvements in Poplar and Strathmore and is expected to complete the remaining asphalt tie-in work with the next week. Once complete, the contractor will have minor items of work, including street sign replacement and site cleanup before the project will be accepted as complete by the Engineer. It is anticipated that all work will be complete by the middle of September and that the project will be taken to the Board for formal acceptance before the end of October.

**2019 RRAA Project 1**: This project was awarded to Teichert Construction as part of the July 23<sup>rd</sup> BOS meeting. Construction will begin September 3<sup>rd</sup> and should be completed by the end of November.

**2019 RRAA Project 2:** This project was originally scheduled to award the construction contract on August 20<sup>th</sup>. However, upon careful examination of the bid proposals, staff discovered that the apparent lowest bidder made a clerical error in its base bid. Due to the potential risk of litigation, staff will be requesting the Board of Supervisors reject all bid proposals received for this project at the September 10<sup>th</sup> Board meeting. Project will be re-advertised for construction in October.

**Road 192 & Road 204 Rehabilitation Project**: This project was awarded to Agee Construction as part of the August 13<sup>th</sup> BOS meeting. Construction will begin in late September and the project is expected to be completed by the end of November.

**Avenue 232 Safety Improvement Project**: The environmental, NEPA and CEQA NOE, is complete for this safety project. We are currently in the right-of-way (ROW) acquisition and utility relocation process. In order to proceed with the ROW acquisition for the improvements; Plats & Legals were received and notification to the CA Department of Conservation of the intent to acquire property within agriculture preserve was complete on August 23<sup>rd</sup>. Once the Utility relocation coordination is complete, the appraisal phase will begin. The 60% PS&E will be out for review within the next week.

**Road 64 Improvement Project**: This project includes reconstruction and widening along Road 64 from Route 198 to Avenue 30. To aid with the right-of-way acquisition process, a public outreach meeting was held on August 21, 2019 at Goshen Elementary School. Based on the feedback obtained, staff can now make slight adjustments to the design.

**Avenue 80 Railroad Crossing Improvements**: We are pending the signal design and estimate from UPRR. The next phase will be to finalized the PS&E and prepare for construction phase authorization.

**Earlimart ATP Sidewalk Improvements**: Design for this project is underway. Construction for this project is anticipated to begin in late Summer of 2020.

**Avenue 328 Safety Improvement Project:** This project was awarded in HSIP Cycle 7. The scope includes the installation of left-turn lanes along Avenue 328 at the intersections of Road 112, Road 138, and Road 156. The completion of 35% design is anticipated by the end of September.

Avenue 256 & Road 204 Signalization and Rehabilitation Project: Design is currently underway.

#### ASSISTANCE TO ECONOMIC DEVELOPMENT/PLANNING PROJECTS

Public Works provided GIS Maps to other branches of the Resource Management Agency. In August 148 maps were provided to the Planners for 21eparate projects.


#### **ENCROACHMENT PERMITS**

In August staff processed a total of 59 new encroachment permit applications. The permit processing numbers and inspections increased again this month and remain at high levels. County inspectors provided oversight and daily inspections for 35-40 daily/recurring active projects, and 4 tracts/parcel improvement projects. August Permit Large Project Review:

- Wide area upgrades to AT&T telecom lines;
- Gas Co- *ENC1900422*.

#### August Permits Processed:

- Processed and issued a total of 167 transportation permits comprised of: 18 rider permits, 18 single-trip permits (including over-sized or overweight loads) and 131 blanket/annual permits;
- Issued 4 sub-encroachment permits for inspections of job sites under utility company annual/blanket maintenance permits, as well as reviewed sites, signing and safety for dozens of short-term repairs;
- Reviewed routing and issued permits for 2 house structure relocations;
- Processed documents, reviewed traffic control plans/routes, and issued 2 special event/parade permits.



Staff provided inspections and oversight for the following major projects while continuing to provide service to general permits including:

**Gas Company** – ENC1900351 **PSEP Gas Pipeline Pressure Betterment Project:** An additional phase to the series of pipeline upgrades that have been installed for the past few years, linking sources in Tulare, Tipton, Cotton Center, Poplar and south Tulare County to upgraded services with larger delivery capacity. This project is installing a 16-inch steel pipeline along the shoulder of Avenue 152, starting near Tipton and continuing east to a junction station near Road 168. Work is scheduled to be ongoing for several months. Engineering estimated cost of project, approximately \$8,000,000.



- Edison *ENC1900151* Improvements of Transmission services to the City of Woodlake, Tract Map– *TSM17-001/* Quail Ranch;
- Parcel Map Improvements/Sequoia Commons (Self-Help Enterprises;

#### TREE MORTALITY

Tulare Country Fire hand crews felled 412 high hazard trees in the County's right-of-way of the Western Divide area in August.

### MANAGEMENT GROUP 3:

#### TRANSIT

Staff implemented the changes to Routes 60, 70, 80, & 90 and Lindsay Dial-A-Ride August 5, 2019 as previously presented to the Board. These changes include serving Ducor on Route 80, realigning Route 90 to include the South County Detention Center and the new Altura Health Center in Woodville, adding a stop in Strathmore on the new Route 90, and converting the Lindsay Dial-A-Ride bus into a fixed route bus during off-peak hours.

Staff also provided a presentation to the City of Lindsay city council on August 13, 2019 regarding these changes.

Staff also gave a presentation to the Grand Jury on August 12, 2019 regarding the transit



system focusing on service, funding, buses and contracted drivers.

The following graph and chart compare this fiscal year's transit ridership to last fiscal year's ridership, both month-to-month and fiscal-year-to-date. This data has generally been presented on one-month delay to account for the reporting deadline in the transit services contract. As such, the chart here shows data for July:

Staff are working to revamp the transit ridership report and will provide a separate transit report for FY2018/19 in the near future. Staff are also aiming to revamp these monthly reporting activities in the coming months to comply with the current Transit Development Plan which recommended productivity metrics and benchmarks be prepared and reviewed on a monthly basis.

#### ZONES OF BENEFIT

Operations and maintenance of Zones of Benefit sewer systems continued with **no spills** for the month of August 2019.

Operations and maintenance of Zones of Benefit water systems continued in August 2019 with no known service interruptions in Yettem and Delft Colony.

On August 17, 2019 the Seville Water system experienced brief water outage due to an electrical failure which caused the equipment to fail. Due to the possibility of disruptions in service in Seville, users were notified of the repairs via phone call using the AlerTC system and were reminded of the ongoing "Boil Water" notice. Portable toilets continue to be provided to Stone Corral Elementary School and two 5,000gallon non-potable water tanks are available to the school and the community.

On August 20, 2019, the County Board of Supervisors conducted a Public Hearing to consider water rate adjustments for the Yettem Water System and the Seville Water System. The number of valid protests was below 50% of the property owners and the proposed fee adjustment was approved by resolution 2019-0734. The new rates shall go into effect on September 1, 2019 and will appear on the October 2019 customer bills. This step also helps clear one of the LAFCO conditions before the County may transfer the water systems to the Yettem-Seville CSD.

The table below summarizes the water production and wastewater treatment for the month of July, as this data is not provided by the contractor until mid-month. There is no data for the lift station at El Rancho, as there is no flow totalizer.

#### WATER/SEWER PROJECTS

Construction of Phase 1 of the Yettem-Seville Water System Improvement Project in ongoing. Staff met with the Division of Drinking Water on August 7<sup>th</sup> to discuss the transition plan from the old system to the new system. A follow up meeting between Self Help Enterprises, CSET and the Division of Drinking Water will be held in September. The Contractor has been paid for 24.60% of the contractor amount for work completed before July 31<sup>st</sup>.

Staff continue to work on the Phase 2 grant application for the interconnection of the Yettem and Seville Water Systems. Staff intend to present a draft application to the Board in October.

#### SEQUOIA FIELD AIRPORT

Staff are in the final phases of preparation of the construction documents and will rebid the Navigational Aids project. It is the intent of RMA to advertise the project by mid-September. In accordance with the directives of the FAA the PAPI lights will be furnished as construction materials to the contractor with the lowest most responsive base bid. Staff anticipate a three-week advertisement of the project. Staff have provided to the FAA the final exhibits required for close out the ALP plan grant.

One of the airport tenants, Vortex Powered Paragliding, held a gathering for paragliders over Labor Day weekend. About 50 powered paragliders came from across the state and held discussions and flying demonstrations.



#### FLOOD CONTROL

There was no Flood Commission meeting in August.

The Encroachment Permit Application to the Bureau of Reclamation for the Strathmore Flood Control Project is on hold until issues with the Friant Kern Canal Authority (FKCA) have been resolved. A meeting has been scheduled with the FKCA, Bureau of Reclamation and Tulare County to sort out FKCA concerns. Staff continues to finalize technical specifications.

Staff are working to prepare for the annual preseason flood coordination meeting, which will be held in September or early October.

#### TOMF and CNG Fueling System Project

#### **Transit Operations and Maintenance Facility Project:**

Based on the current work schedule, this project will be nearing completion in mid-October, approximately three months ahead of the planned completion date. The contractor, Seals Construction, Inc. continued its work within the Operations Building while multiple subcontractors work throughout the site. Work completed in August includes installation of lockers in the restroomsn sineage, and the HVAC "Energy Recovery Ventilator" unit and corner guard. The work completed within the Maintenance Building included floor polishing, roof-top cooler and blower installation, fire-line connections, and continued work on the building electrical systems. Site improvements also continued through out the project; these components include light pole installation, concrete replacement in damaged areas, monument sign installation, irrigation line installation and fence erection. Heavy gauge metal gates for the trash enclosure and the mechanical yard were installed. Crews also painted the CMU block walls throughout the jobsite to match the same two-tone coloration of the buildings.

Southern California Edison was on site to approve the underground switchboard panel infrastructure. With the approval of the elements it is anticipated that power will be provided to the site by late September. Southern California Gas was able to complete the connection between the Maintenance Building and the SCG mainline located adjascent to Road 140 in August as well. With this work completed the gas meter was installed and ready for tun on.

#### **CNG Fueling System Project:**

Hobbs Construction submitted product data and samples submittals as well as submittals for implementation of a Storm Water Pollution Prevention Plan (SWPPP). This is a combined effort between the TOMF contractor and Hobbs Construction. The contractor marked the area for underground service locations. Commencement of the project is anticipated within the next few weeks.

In August County staff was in contact with Southern California Gas to follow up on the pressure request to provide service to the upcoming CNG Fueling Facility. They have advised the pressure request has been conditionally accepted pending the installation of the Tulare betterment project which will increase the presure of the line feeding the proposed fueling system. Southern California Gas anticipated the betterment project will start in October and will be completed by February 2020.




