## NOTICE OF PUBLIC HEARING ZONE CHANGE PZC 24-006 AND TENTATIVE SUBDIVISION MAP NO TSM 24-001

NOTICE IS HEREBY GIVEN that the Tulare County Board of Supervisors will hold a public hearing on Tuesday, January 28, 2025, at 9:30 a.m., or as soon thereafter as it can be heard, in the Chambers of the Board of Supervisors, Administration Building, County Civic Center, 2800 West Burrel, Visalia, California.

The hearing pertains to Zone Change No., PZC 24-006 to change the zoning from A-1 (Agricultural) Zone to R-A-43 (Rural Residential – 43,000 square foot minimum) Zone and Tentative Subdivision Map No., TSM 24-001 to divide four (4) parcels (Existing Parcel 1 = 1.76 acres, Existing Parcel 2 = 2.38 acres, Existing Parcel 3 = 2.61 acres, and Existing Parcel 4 = 2.64 acres) into eight (8) parcels (Proposed Parcel 1 = 1.76 acres, Proposed Parcel 2 = 1.39 acres, Proposed Parcel 3 = 1.39 acres, Proposed Parcel 4 = 1 acre, Proposed Parcel 5 = 1 acre, Proposed Parcel 6 = 1 acre, Proposed Parcel = 1 acre, Proposed Parcel 7 = 1 acre, and Proposed Parcel 8 = 1 acre), on the east side of Belmont Road (Road 198) and approximately 1,000 feet north of Meadow Avenue within the Exeter Urban Development Boundary. The site is within Section 3, Township, 19 South, Range 26 East, MDB&M (APNs: 138-010-064 and 138-010-092). Under the California Environmental Quality Act (CEQA), a Categorical Exemption which is consistent with CEQA and the State CEQA Guidelines pursuant to Title 14, Cal. Code Regulations, Section 15303, Class 3, pertaining to New Construction or Conversion of Small Structures, as parcels 5-8 of the proposed parcels would allow for a minimum of one (1) residence to be constructed.
