1 ORDINANCE NO. 3641 2 AN ORDINANCE AMENDING ORDINANCE NO. 352, THE ZONING ORDINANCE 3 OF TULARE COUNTY, PERTAINING TO SECTION 16 TO ALLOW ADDITIONAL "BY-RIGHT USES" IN KINGSBURG AREA, UNLESS OTHERWISE PROVIDED IN THIS 4 5 ORDINANCE PZC 23-007. THE BOARD OF SUPERVISORS OF THE COUNTY OF TULARE DO ORDAIN AS 6 7 FOLLOWS: 8 Section 1. Section 16 is hereby amended to Tulare County Ordinance No. 352, as 9 amended from time to time, to read as follows: 10 The following regulations shall apply in the communities of the Kingsburg Area, Cutler/Orosi, 11 Lemon Cove, Ivanhoe, Woodville, Plainview, Poplar/Cotton Center, Three Rivers, Goshen, Ducor, 12 Terra Bella, Traver, Strathmore, Pixley, Tipton, Earlimart, Alpaugh, East Orosi, London, 13 Richgrove, Sultana, El Monte Mobile Village, Hypericum, Jovista, Matheny Tract, Tooleville, 14 Allensworth, Delft Colony, East Tulare Villa, Lindcove, Monson, Seville, Teviston, Tonyville, 15 Waukena, West Goshen, and Yettem, unless otherwise provided in this Ordinance unless 16 otherwise provided in this Ordinance. All of the following, and all structures and accessory uses directly related thereto in this section 17 18 are entitled without a Special Use Permit (Conditional Use Permit). The following is allowed 19 only in the various zones indicated below and within a community plan that adopted 20 development standards for such entitled use. The proposed use must adhere to the adopted 21 development standards of the community. The proposed use must also qualify for an exemption 22 under the California Environmental Quality Act as determined by the Permit Center. The Permit 23 Center will review the project for General Plan Policy, Community Plan Policy and development 24 standard consistency and determine which environmental document is appropriate. Projects 25 where the Permit Center is unable to make an immediate determination will be required to go 26 through the Project Review Committee (PRC). 27 Uses that have an environmental effect on adjacent properties or necessitate mitigation measures 28 through the California Environmental Quality Act will be required to apply for a PRC and a 29 traditional use permit and legislative process through the County. Projects with a square footage 30 of 80,000 or more will also require a traditional use permit. Uses may have environmental or land use issues that may not be compatible with adjacent uses. These impacts may include but 31
