## I. CALL TO ORDER – 9:01 A.M. – Open Session

A quorum was recognized at the regular meeting of the Tulare County Treasury Oversight Committee and the meeting was called to order by member Steve Tsuboi.

II. <u>REVIEW OF MINUTES</u>-Approve the April 25th, 2019 minutes as presented.

The April 25<sup>th</sup> 2019 minutes were reviewed by the committee. With no corrections needed a motion to approve was made by Marc Lippincott and seconded by Jason Britt. The motion was carried.

### III. TREASURY BUDGET UPDATE

Frank Vigario presented the current approved Treasury budget and projected actuals for quarter ending June 30, 2019. No action was taken.

## IV. PFM ECONOMIC UPDATE

Lauren Brant and Tim Stidham, provided an economic update and investment performance review for the quarter ending June 30th, 2019. No action taken.

### V. QUARTERLY REPORT

Frank presented the committee with the Quarterly Report for quarter ending June 30<sup>th</sup>, 2019. The investment activity for the quarter was in compliance with the California Government Code and the approved Statement of Investment Policy. The net (after fees) earnings rate for the period was 2.20%. Upon review of the Quarterly Report a motion to accept the report was made by Eric Limas and seconded by Jason Britt. The motion was carried.

### VI. TREASURY DEPARTMENT UPDATE

Paul Sampietro presented the committee with a Treasury department update. The Treasury department is working with a contract auditor to draft a banking RFP which should be going out soon. Discussions are also in the works with our constituencies to determine the most efficient and secure bank account structure. The goal is to select a bank with a footprint in Tulare County while maintaining the level of customer service expected, and upgrading some of the processes. This should take the better part of the 2020 fiscal year to complete. The cash recycler is slated to be installed in September.
