Frank presented the committee with the Quarterly Report for quarter ending September 30, 2018. The investment activity for the quarter was in compliance with the California Government Code and the approved Statement of Investment Policy. Upon review of the Quarterly Report a motion to accept the report was made by Stan Bennett and seconded by Steve Tsuboi. The motion was carried.

### VII. TREASURY DEPARTMENT UPDATE - Presented by Paul Sampietro

A Treasury department update was provided to the committee. Paul reported that the department was in the process of obtaining global payment advisors which will do an in depth, internal audit of the Treasury and the County controls. The target date for this is January 2019. He also advised that to improve the yield and the activity on the liquid portfolio a review of the cash flows is in process by Victor Arellano to develop a projection. The review is in its early stages and is a work in progress. The projections will enable the Treasury department to move some cash into higher yielding liquid securities.
