I. CALL TO ORDER - 9:02 A.M. - Open Session

A quorum was recognized at the regular meeting of the Tulare County Treasury Oversight Committee and the meeting was called to order by member Steve Tsuboi.

II. **REVIEW OF MINUTES**-Approve the April 22,2021 minutes as presented.

The April 22, 2021 minutes were reviewed by the committee. A motion to approve was made by Cass Cook and seconded by Jason Montgomery. The motion was carried unanimously.

III. TREASURY BUDGET UPDATE

Frank Vigario presented the current approved Treasury budget and projected actuals for quarter ending June 30, 2021. Frank reported the 2021 fiscal year ended under budget by \$232,000. This was due to the reduction in banking charges, a transition credit from JP Morgan, the lack of need of the originally budgeted banking consultant, the lack of travel expenses due to Covid19 and \$10,000 in CARES funding. Frank reviewed the proposed budget for 2022. The committee had no questions, and no action was taken.

ECONOMIC UPDATE – Presented by PFM Asset Management IV.

Representatives from PFM Asset Management provided an economic update and investment performance review for the quarter ending June 30, 2021. It was announced that PFM would be merging with US Bank at the end of 2021. No action was taken.

V. QUARTERLY REPORT -Quarter ending June 30, 2021

PFM presented the committee with the Core portion of the quarterly report.

Frank Vigario presented the committee with the Liquidity portion of the quarterly report. Jason Montgomery made a motion to accept the quarterly report and Eric Limas made the second. The motion was carried unanimously.

VI. TREASURY DEPARTMENT UPDATE-Presented by Paul Sampietro

Paul Sampietro provided an update regarding the Treasury Department. Paul reported that the department was still working on the remodel with no updated timeline available. Frank added that the Treasury Department was changing Custody as Union Bank sold their Custody Department to US Bank. Paul reported that extra cyber security measures were put into place during the banking transition.
